Sievers became CEO of AltaOne in May 2021 and since has shepherded the credit union through a bank branch acquisition in Ridgecrest CA; opened a de novo branch in Tehachapi CA; joined the Co-Op ATM and shared branching networks; received the Community Development Financial Institution certification; expanded business products and services and implemented a 5year strategic plan—resulting in lending, deposit and membership growth and a decrease in employee turnover.
